**Conditions of Participation**

The right of use is unlimited and permanently free of charge.
3. The following liability regulation applies between the participants and HEAD Sport GmbH: HEAD Sport GmbH is only liable for intent and gross negligence including the actions of its own employees. This limitation of liability does not apply if it concerns so-called basic obligations from the contractual relationship. Otherwise, the assignment of claims requires the prior written consent of HEAD Sport GmbH. Participants accept that the event organizers can immediately exclude the participating person from participation in case of gross violations or other violations previously objected to by HEAD Sport GmbH.
